

Privacy Statement E-Gereo B.V.

With this Privacy Statement, E-Gereo B.V., having its office at (9982 EG) Uithuizermeeden, Kaapweg 2, with chamber of commerce number: 02013386 (hereinafter: "Elzinga Groep"), explains which personal data it collects and processes and for which purposes, and what its cookie policy is.

General information

Elzinga Groep respects the privacy of all the visitors of its website <https://elzingagroep.nl>, its (potential) clients and other (potential) relations of Elzinga Groep. Personal data provided to Elzinga Groep, will be dealt with and secured with the greatest care possible. Your personal data will not be sold or traded, nor shared with organisations or individuals that are not related to the services of Elzinga Groep in any way. In any event, Elzinga Groep processes data in compliance with the requirements laid down by the Dutch Personal Data Protection Act ("Wet Bescherming Persoonsgegevens").

Personal data

If you use the services of Elzinga Groep or if you have contacted Elzinga Groep, for example by sending an email or by using the contact form on the website of Elzinga Groep, Elzinga Groep will save the personal data provided by you. Elzinga Groep only saves and processes the personal data as provided by you.

Elzinga Groep will use your personal data to provide the best service possible. Your personal data will solely be used for this purpose. Your personal data shall not be shared with third parties without your written consent, unless it is necessary for the execution of the agreement you concluded with Elzinga Groep or it this is required by law.

Your personal data will be kept for as long as the nature of the contact between you and Elzinga Groep is needed in the opinion of Elzinga Groep.

You can visit the website of Elzinga Groep without providing any personal data to Elzinga Groep at any time.

Cookies

Elzinga Groep makes very limited use of cookies. Cookies are very small text files that are stored on the hard drive of your computer, tablet or smartphone.

Elzinga Groep also uses Google Analytics. Analytics cookies are used to map and analyse website use, with the goal of improving the quality and/or effectiveness of the website. Google may provide this information to third parties if Google is required by law to do so, or if these third parties process the provided data on Google's behalf. Elzinga Groep does not have any influence on this matter. However, Elzinga Groep does not allow Google to use the provided analytics for other Google services.

Third parties do not have access to the cookies Elzinga Groep uses. If you are completely opposed to the idea of websites storing cookies on your computer or peripheral devices, you can always adjust your browser settings. These proceedings however only affect that particular device and browser. In the event you use more computer and/or browsers, you need to repeat these proceedings as many times necessary.

Refusing cookies may stop the website of Elzinga Groep from functioning properly.
